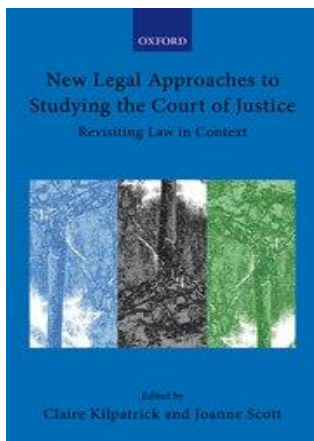

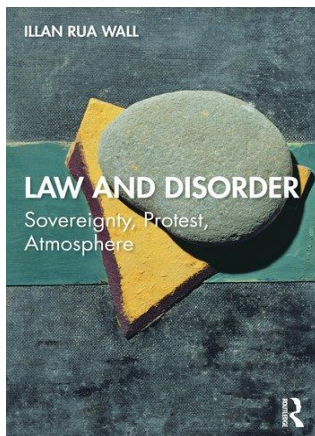
[New Legal Approaches to Studying the Court of Justice: Revisiting Law in Context](#)

At the beginning of 2015, the Court of Justice opened its archives, which created a new and challenging primary source for those studying the Court of Justice: the *dossiers de procedure* which contain much more than the contemporary documents published by the Court. This volume includes five chapters which analyses the activities of the Court of Justice from a highly diverse range of non-doctrinal perspectives. However, they also highlight significant new developments at the Court itself which attract attention and deserve analysis. Thus, the idea behind this volume is to make available new tools and approaches through which the activities of the Court of Justice can be studied. It shows a more intense engagement with scholars across disciplines to reflect on law and courts, with the Court of Justice as a central focus, and new methods (such as network citation analysis) and sources (such as the Court's archives) being discovered and developed. It also shows a more intense and deeply knowledgeable engagement with EU law and the Court of Justice by non-legal scholars, such as the new sociologies and histories of the Court of Justice. Confronting the Death Penalty: How Language Influences Jurors in Capital Cases probes how jurors make the ultimate decision about whether another human being should live or die. Drawing on ethnographic and qualitative linguistic methods, this book explores the means through which language helps to make death penalty decisions possible - how specific linguistic choices mediate and restrict jurors', attorneys', and judges' actions and experiences while serving and reflecting on capital trials. The analysis draws on fifteen months of ethnographic fieldwork in diverse counties across Texas, including participant observation in four capital trials and post-verdict interviews with the jurors who decided those cases. Given the impossibility of access to actual capital jury deliberations, this integration of methods aims to provide the clearest possible window into jurors' decision-making. Using methods from linguistic anthropology, conversation analysis, and multi-modal discourse analysis, Conley analyzes interviews, trial talk, and written legal language to reveal a variety of communicative practices through which jurors dehumanize defendants and thus judge them to be deserving of death. 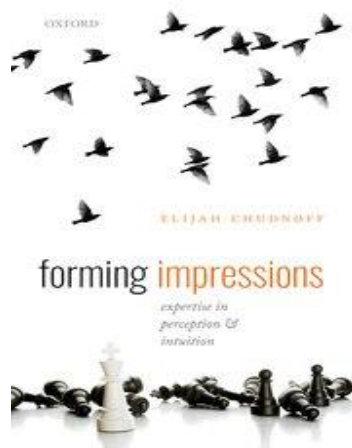
[Ownership and Inheritance in Sanskrit Jurisprudence](#)

Ownership and Inheritance in Sanskrit Jurisprudence provides an account of various theories of ownership (svatva) and inheritance (dāya) in Sanskrit jurisprudential literature (Dharmaśāstra). It examines the evolution of different juridical models of inheritance—in which families held property in trusts or in tenancies-in-common—against the backdrop of related developments in the philosophical understanding of ownership in the Sanskrit text-traditions of hermeneutics (Mīmāṃsā) and logic (Nyāya) respectively. Christopher T. Fleming reconstructs medieval Sanskrit theories of property and traces the emergence of various competing schools of Sanskrit jurisprudence during the early modern period (roughly fifteenth-nineteenth centuries) in Bihar, Bengal, and Varanasi. Fleming attends to the ways in which ideas from these schools of jurisprudence shaped the codification of Anglo-Hindu personal law by administrators of the British East India Company during the late eighteenth and early nineteenth centuries. While acknowledging the limitations of colonial conceptions of Dharmaśāstra as positive law, this study argues for far greater continuity between pre-colonial and colonial Sanskrit jurisprudence than accepted previously. It charts the transformation of the Hindu law of inheritance—through precedent and statute—over the late nineteenth, twentieth, and early twenty-first centuries. [More Details...](#)



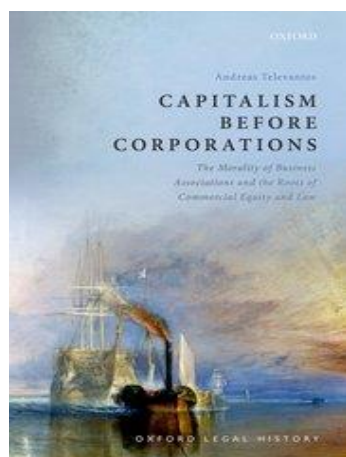
Forming Impressions: Expertise in Perception and Intuition

Perception and intuition are our basic sources of knowledge about the concrete world around us, and more abstract matters such as mathematics, metaphysics, and morality. Perception and intuition, however, are also capacities we deliberately improve in ways that draw on our knowledge about these domains. How can the sensory and intellectual impressions that lie at the foundation of our knowledge themselves be informed by our knowledge? In *Forming Impressions: Expertise in Perception and Intuition*, Chudnoff addresses this and other questions that derive from trying to understand the improvability of our basic sources of knowledge. At the extreme of improvement lies expertise, and there is a wealth of research on the structures and mechanisms underlying expert perception and expert intuition that promises to illuminate the nature and significance of improvements to these sources of knowledge in general. Taking this cue, the first part of the book lays the groundwork for the rest by elaborating an interpretation of the psychology of expertise. The second part develops a setting for thinking about the epistemology of expert perception and expert intuition. The third part of the book explores the significance of the resulting view of intuition and its improvability for recent debates about philosophical methodology. Chudnoff defends a rationalist view of the role of intuition in philosophy that can be traced back to classic works on methodology such as Descartes' Rules and Spinoza's Emendation of the Intellect.
